#### MANUFACTURING MANUFACTURING

The Reference Product comes from sites that have received ISO 14001 certification.

Specific distances of transport before and after manufacturing were not available, but based on the use of local suppliers and sale within in North America, "Local transport" default distance of 621 miles (1,000 km) by heavy truck to the manufacturing site and to local distribution centers was included in the manufacturing stage.



#### DISTRIBUTION

Products are distributed from logistics centers located to optimize transport efficiency using EPA SmartWay\* certified carriers to reduce greenhouse gases emissions. Information on the distance of distribution is not available so the PCR hypothesis for "Intercontinental transport", 2175 miles (3500 km) by heavy truck, was used. This represents transportation of the Reference Product from our warehouse to the local point of distribution in the North American market.

## ■ ENVIRONMENTAL IMPACTS ■

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use, and end of life. It is representative of products marketed and used in North America.

The following modelling elements were taken into account:

Manufacturing	All transport for the manufacturing of the Reference Product, including materials and components, has been taken into account. Production of raw materials and packing, as well as the product manufacturing is accounted for. The waste generated during manufacturing phase has been included for non packaging materials. Manufacturing process have been accounted for using electricity, fuel and water use for the steel processing portion of the facility.
Distribution	Transport between the last distribution center and an average delivery to the sales area. The default scenario modelled maximizes the environmental impact.
Installation	The end of life of the packaging (3.5 lb or 1585 g) and its transport to end of life treatment is taken into account at this phase.


