

## **SLIM 5 SERIES INSTALLATION**

- 1) Install the runners to the enclosure bottom through the holes shown using the supplied hardware. (FIGURE A)
- 2) Install the screws and nuts as shown. (FIGURE B)

**<u>NOTE</u>**: If your Slim 5 does not have the center holes, perform the following steps:


- 1) Install the runners using the two outer holes.

- 3) Install the remaining nuts and bolts.




